Riga was founded in 1201 and is a former Hanseatic League member. Its historical centre is a UNESCO World Heritage Site, noted for its Art Nouveau/Jugendstil architecture and 19th century wooden architecture. Riga was the European Capital of Culture during 2014 and has, in the past, hosted the NATO Summit, numerous sporting world championships and the Eurovision song contest. Riga is home to the European Union's office of European Regulators for Electronic Communications (BEREC). This year the city and its region have been granted the title of the European Region of Gastronomy.

Riga is one of the key economic and financial centres of the Baltic States. Roughly half of all the jobs in Latvia are in Riga and the city generates more than 50% of Latvia's GDP, as well as around half of Latvia's exports. The biggest exporters are in wood products, IT, food and beverage manufacturing, pharmaceuticals, transport and metallurgy. Riga's port is one of the largest in the Baltic States, with future growth at the new port developments on Krievu Sala. Tourism is also a growth industry in Riga and has grown rapidly in the last five years. It is served by Riga International Airport, the largest and busiest airport in the Baltic States, offering more than 60 direct flight destinations all over the world. At the same time, the city is situated on the most significant road connections between Finland and the Czech Republic.

As an insolvency practitioner it is always a balance to meet certain interests, but at the same time follow and use the different legal frameworks. That's why the title of the next conference will be **"Balance of interests: restructuring, insolvency and second chance"**. The congress will be focused mainly on new approaches across Europe towards (cross-border) insolvency, how local and European laws have developed and the Commission's plans for harmonization of the Member States' insolvency laws. The Congress will consider the possibilities in different European jurisdictions for financing and other crucial tools to save as many companies as possible where there is a viable business.


